Listening and Spoken Language Specialist (LSLS) mentorship (3 credit hours/academic year): I facilitate a study group twice a month for Sound Beginnings staff seeking Listening and Spoken Language Specialist (LSLS) certification. The goal is to prepare qualified candidates for the LSLS exam and to position them to be effective listening and spoken language specialists (AVT or AVEd). As a mentor, I review the current eligibility requirements and ensure adherence to the Principles of LSLS for the applicant's intended designation (Auditory Verbal Educator or Auditory Verbal Therapist). I have developed, and will continue to refine, a Canvas course (*LSLS Certification Exam Preparation*) to provide course structure and a place for where the mentees are able to access resources and quizzes. I provide structured feedback and guidance to professionals seeking certification upon observations of sessions and classes utilizing the Mentor's Evaluation Form created by the Alexander Graham Bell Academy.

Coordination of Family Education and Support Group (FESG) program of Sound Beginnings and student rotations: I coordinate programming for FESG, a program which aligns with my research interests in family-professional partnerships. Coordination of FESG involves co-planning education modules, preparing presentations to parents, enlisting speakers, standardizing guidelines for presentations, and working with volunteers. I strongly believe that our LSL students should have the opportunity to develop their parent-professional collaboration skills. I am coordinating the AuD and Deaf education student rotations so that they may experience the value of a parent-professional collaboration and learn about the different components of an effective family education program. Their rotation includes co-teaching an education session presentation to families, observing support group meetings, and assisting in the Sibling Support Program.

Coordination of webinars on Hear to Learn website (heartolearn.org): I coordinate the educational free webinars that are available to parents and professionals. These webinars are available offered once a month and are available in English and Spanish.
